Step II: Reason for Filing a Special Circumstance Form

Check (✓) the circumstance that applies to your situation. Required documentation to support you or your spouse's circumstance **must be attached**.

A. You (or your spouse) earned money in 2008 but have lost your full-time job in the last ten (10) weeks and are still unemployed.

Required Documentation:

1. Statement from ALL previous employer(s) you (or your spouse) worked for in 2008 and/or 2009 on company letterhead indicating:
 - Date you (or your spouse) ceased employment
 - Total earnings for the ENTIRE year of 2008
 - Wages for 2009 (if employment ceased in 2009); and
2. A current statement of unemployment benefits received.
3. Copy of your (and your spouse's) 2008 federal 1040 tax return

B. You (or your spouse) earned money in 2008 but have changed employment and are currently earning substantially less money in 2009.

Required Documentation:

1. Statement on company letterhead from ALL employers you (or your spouse) worked for in 2008 and/or 2009 indicating:
 - Dates of employment
 - Your (or your spouse's) estimated earnings for 2009;
2. Your (or your spouse's) 2008 W-2 form(s)
3. Copy of your (and your spouse's) 2008 federal 1040 tax return

C. You (or your spouse) received unemployment compensation or some other taxed or untaxed income or benefit for at least ten (10) weeks in 2008 but have completely lost that income or benefit.

Required Documentation:

1. Statement of termination from the source of income. *Include* dates he/she received the benefits.
NOTE: Income and benefits include such things as: Social Security benefits, court-ordered child support, retirement or disability benefits. Don't include loss of veteran's educational benefits.

2. A statement from the source of the income or benefit indicating the dates he/she received the income benefit and the estimated income or benefit received in 2008.
3. Copy of your (and your spouse's) 2008 federal 1040 tax return

D. After you applied for financial aid for 2009-2010, you and your spouse have separated or divorced.

Required Documentation:

1. Copy of your (and your spouse's) 2008 federal 1040 tax return;
2. Copy of your 2008 W-2 form(s); and
 - **If you are separated:** Attach a notarized statement indicating the date of separation; or
 - **If you are divorced:** Attach a copy of the divorce decree.

E. Since you applied for financial aid for 2009-2010, a supporting spouse has died.

Required Documentation:

1. Copy of your spouse's death certificate;
2. Copy of your 2008 federal 1040 tax return; and
3. Copy of your 2008 W-2 form(s).

F. You (or your spouse) received a one-time income supplement in 2008, such as Social Security payment, inheritance, IRA, or pension distribution.

Required Documentation:

1. Copy of your (and your spouse's) 2008 federal 1040 tax return;
2. Statement from source of one-time income indicating amount; and
3. Statement from you indicating the disposition of the funds.

G. You paid out (not owed) a large amount of medical and/or dental expenses in 2008.

- 1. Copy of your (and your spouse's) 2008 federal 1040 tax return
- 2. Copy of your 2008 federal income tax Schedule A; and
- 3. Copies of the medical and dental payments not covered by insurance that you have already paid.

- 1. Copies of paid receipts for private or parochial elementary and/or secondary tuition; or
- 2. A statement from the education institution indicating tuition paid in 2008.
