

## 2019-2020 Dependent Verification Worksheet

## Federal Student Aid Programs

Your 2019–2020 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we must ask you to confirm the information you and your parents reported on your FAFSA. To verify that you provided correct information our staff will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and at least one parent must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the Student Financial Services office. We may ask for additional information. If you have questions about verification, contact our office as soon as possible so that your financial aid will not be delayed.

## B. Dependent Student's Family Information

## C. Income Information

**Instructions**: The best way to verify income is by using the IRS Data Retrieval Tool that is part of FAFSA on the Web at <a href="www.fafsa.gov">www.fafsa.gov</a>. In most cases, no further documentation is needed to verify 2017 income and tax information that was transferred into the student's FAFSA using the IRS Data Retrieval Tool, as long as that information was not subsequently changed. It takes up to 2 weeks for IRS income information to be available for the IRS Data Retrieval Tool for electronic IRS tax return filers, and up to eight weeks for paper IRS tax return filers. **Important Note:** If the student/parent filed, or will file, an <a href="amended 2017">amended 2017</a> IRS tax return, the student/parent must send a signed copy of your amended return to the Trinity financial aid office.
